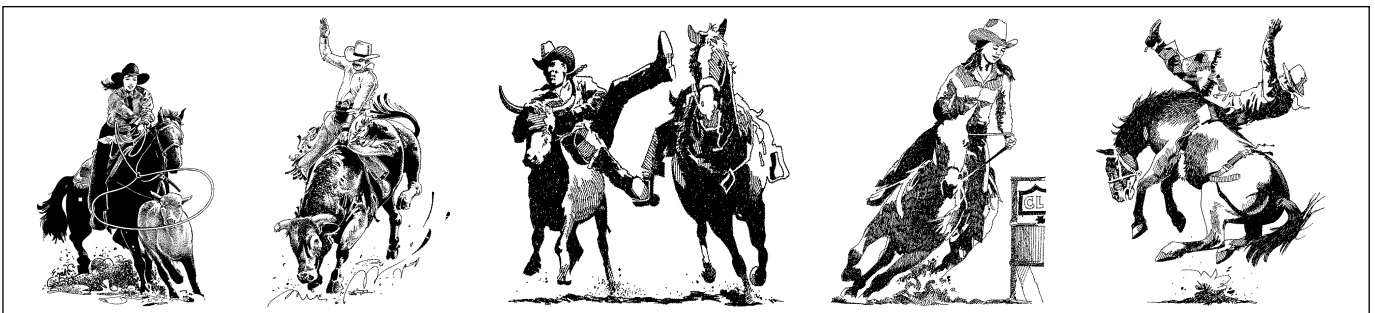

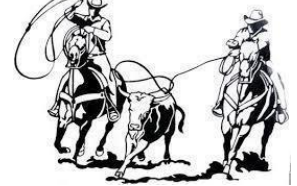

Affiliation Classifications



Option 1:

SUPER ALL ROUND RODEO (FULL POINTS & A HALF AWARD)

- ❖ For the Super all-round point rodeo, the required events are the standard events.
Standard events are:
Six (6) men's events – *Bull Ride / Saddle Ride / Bareback Ride / Rope & Tie / Steer Wrestling / Team Roping*
Two (2) ladies' events – *Barrel Race / Breakaway Roping*.
- ❖ Minimum prizemoney total \$12000.00, consisting of \$1500.00 minimum per standard event.
- ❖ Optional events may be conducted with minimum prize money of \$300.00 per event.
- ❖ Junior and/or novice events can only be held if the equivalent senior event is being conducted.
- ❖ Team Roping may be conducted as a one (1) run event with double the minimum super prizemoney.
- ❖ Competitors receive full points and a half to event titles and all-round titles.
- ❖ Free half-page advertisement in the newsletter.
- ❖ In the draw to win free affiliation for the following year.
- ❖ Must have an Animal Welfare Officer, two (2) NRA accredited Judges, one (1) NRA accredited Chute Boss, two (2) NRA accredited Timekeepers, two (2) NRA accredited Protection Clowns and two (2) NRA accredited Pick up Men.

Option 2:

ALL-ROUND RODEO (FULL POINTS AWARD)

- ❖ For an all-round point rodeo, the required events are the standard events.
Standard events are:
Six (6) men's events – *Bull Ride / Saddle Ride / Bareback Ride / Rope & Tie / Steer Wrestling / Team Roping*
Two (2) ladies' events – *Barrel Race / Breakaway Roping*.
- ❖ Minimum prizemoney total \$6000.00, consisting of \$750.00 minimum per standard event.
- ❖ Optional events may be conducted with minimum prize money of \$300.00 per event.
- ❖ Junior and/or novice events can only be held if the equivalent senior event is being conducted.
- ❖ Team Roping may be conducted as a one (1) run event with double the minimum standard prizemoney.
- ❖ Competitors receive full points to event titles and all-round titles.
- ❖ Must have an Animal Welfare Officer, two (2) NRA accredited Judges, one (1) NRA accredited Chute Boss, two (2) NRA accredited Timekeepers, two (2) NRA accredited Protection Clowns and two (2) NRA accredited Pick up Men.

The Board has the right to negotiate special terms for rodeo affiliation

Option 3:



POINTS AWARD RODEO (HALF POINTS AWARD)

- ❖ For a points award rodeo the required events to be at least three or more of the standard events. (*Bull Ride / Saddle Ride / Bareback Ride / Rope & Tie / Steer Wrestling / Team Roping / Barrel Race / Breakaway Roping*)
Minimum prize money of \$750.00 per event.
- ❖ Half points allocated to individual titles only.
Junior and/or novice events can only be held if the equivalent open event is being conducted.
- ❖ Must have an Animal Welfare Officer, two (2) NRA accredited Judges, one (1) NRA accredited Chute Boss, one (1) NRA accredited Timekeepers, two (2) NRA accredited Protection Clowns and two (2) NRA accredited Pick up Men.

Option 4:



POINTS AWARD BULL RIDE (HALF POINTS AWARD)

- ❖ Limited single (open) event promotions –If sponsorship is available a series can be structured, to be determined by the NRA Board.
- ❖ To consist of an open bull ride, novice bull ride and junior bull ride events (other events may be conducted but must be sanctioned by the Board).
- ❖ Half points for all events allocated to Bull Ride and individual titles.
- ❖ Minimum prizemoney total of \$3000.00, consisting of:
 - Open Bull Ride Minimum of \$2250.00
 - Novice Bull Ride Minimum of \$500.00
 - Junior Bull Ride Minimum of \$250.00
- ❖ If other open events are run a minimum prize money of \$750.00.
- ❖ If other Junior Events are run a minimum prize money at the discretion of the Board.
- ❖ Must have an Animal Welfare Officer, two (2) NRA accredited Judges, one (1) NRA accredited Chute Boss, one (1) NRA accredited Timekeepers, two (2) NRA accredited Protection Clowns and two (2) NRA accredited Pick up Men.

To have a final in an event there must be a minimum prizemoney of \$2250. In the case of a final, the money shall be split evenly over the 1st round, the final and the average with points given on the average only.

The Board has the right to negotiate special terms for rodeo affiliation

Option 5:



NON-POINTS RODEO

(NON-POINTS AWARD)

- ❖ Any rodeo promotion as determined by the board or a promotion that does not meet any of the other rodeo criteria.
- ❖ Must have an Animal Welfare Officer, where there is posted prize money, the officials must be approved by the NRA Board of Directors.

COMMITTEE CHECK LIST

The following checklist has been developed by the National Rodeo Association to assist committees with the conduct of their respective rodeo promotion. If you require any clarification on any of the following points please contact the NRA Office and our administrative staff will endeavour to assist you.

EVENT REGISTRATION

Please register your event with the DPI and advise the ambulance and police in your area of your forthcoming rodeo.

PUBLIC LIABILITY

With regards to Public Liability, if your committee has its own Public Liability cover the NRA Office will require a copy of the policy along with the Certificate of Currency to be sent with the affiliation form and fee. It has been noted that some Public Liability Policies do not include cover for rodeo. **Please look over your policy as the Certificate of Currency should state “Rodeo” in the “description of Activities” or in “The Business”**. – If your policy does not have this written down then the committee will most likely not be covered for rodeo or if your policy has **“Rodeos (excluding any cover for claims inside the arena)”**, then the committee is not fully covered as required.

For example; - if there are any activities or exhibitions held in the break that requires spectators to come into the arena or a spectator decides to enter the arena, back yards and or around the chutes area then the public liability will be required to cover this.

With Gold level Cover with N.R.A, you will be provided with an N.R.A Public Liability (20,000,000.00 Cover) C.O.C that will include your event details and have your event fully covered.

RODEO OFFICE

Please make sure there is a safe & Secure office provided with sufficient Lighting and Shelter for NRA Central Entries personnel to be able to work on Results and nominations and Payouts.

SPECTATOR SAFETY

It is the Committees responsibility to protect the safety of workers and the public. As part of your risk assessment the NRA recommends the best way to do so is with eye-catching and informative signs that alerts workers and the public to the hazard and informs them of the best way to avoid or remedy it.

Clearly displayed signs around the grounds keep spectators clear of any hazards that you cannot remove. Another way of securing these out of bounds areas is to have them roped off with bunting or ropes with signs. It is also frequently needed to keep the public out of areas with high risk such as Arenas, Backyards and Horse warm up zones to avoid any unfortunate and costly public liability claims.

Please ensure that adequate safety precautions are in place for spectators to be informed that they must not be near or on the arena fence. A portable arena is designed to move so spectators must be at least one (1) metre away from the fence or portable panels.

NO SPECTATORS ARE TO BE IN THE ARENA, BEHIND THE CHUTES AND BACKYARD AREA.

(We strongly suggest having security available, they can help ensure these requirements are in place)

ANIMAL WELFARE

In the sport of professional rodeo, cowboys share the limelight with the rodeo livestock. For a cowboy to compete at the highest level, the livestock also must be in peak condition. Both are athletes in their own right. The very nature of rodeo requires a working relationship, and in some events a partnership, between the cowboys and animal athletes. The National Rodeo Association takes animal welfare seriously and is committed to complying with the animal welfare legislation relevant to the state or territory in which the rodeo is conducted.

It is expected that that the operation of any rodeos in Queensland will be conducted in accordance with the Queensland rodeo code of practice. From 1 January 2022, the rodeo code of practice will be a mandatory code under the Animal Care and Protection Act 2001 (the Act). It contains the minimum acceptable standards of welfare for all animals being used at rodeos and rodeo schools.

It is expected that the operation of any rodeos in New South Wales will be conducted in accordance with the NSW code of practice. Compliance with code will ensure that no offence is committed in relation to sections 18 and 18A of the Prevention of Cruelty to Animals Act 1979.

Both codes of practice require the Rodeo Organiser to ensure the following.

- An **Animal Welfare Officer** (Livestock Handler) is appointed for the event. It is recommended that the principal Stock Contractor or Judge be appointed as the Animal Welfare Officer.
- A **Veterinarian** is appointed for the event. The veterinarian must be either in attendance at the event or be available for consultation at all times that animals are present at the event, if not in attendance.
- A **conveyance device** (vehicle) must be available to safely and humanely move a seriously injured animal. Suitable screening (e.g. hessian or tarpaulin) should also be available.

BARREL RACE EVENT

- Barrels must be 44-gallon size (200 litre) steel drums as standard with both ends closed.

OFFICIALS

Judges and officials are to be appointed from the NRA accredited officials list which is published in the bi-monthly NRA Sports News and advertised on the NRA website. www.nationalrodeoassociation.com.au

Please complete the Confirmation of Officials two (2) weeks prior to your Rodeo with names of your Contractors, Judges, Chuteboss, Timekeepers, Pick-up Team and Bull Fighting Clowns, Announcer – all of whom must be NRA Members.

INSPECTION CHECK LIST

The site inspection check list is to be completed and returned to NRA office two (2) weeks prior to your rodeo unless the arena is a portable arena than the site inspection checklist can be completed and handed to the NRA central entries officer on the day of your rodeo prior to the commencement of the Rodeo.

CONTRACTORS

Contractors must be financial members of NRA. All contract stock must be selected from Contractor's listing published in NRA bi-monthly Sport News and website.

FIRST AID

It is mandatory that all committees have a qualified Level Three First Aid Officer in attendance whilst the rodeo is in progress. The First Aid Officer must be Level 3 or above with a fully equipped vehicle (i.e. have the defibrillator on board) to meet the requirements of insurance cover. First Aid Officers must have a designated area outside of the arena with vehicle access to Arena and clear access for vehicle to leave premises in case of an emergency.

ADVERTISING

Committees must display on programs and posters that the rodeo is NRA affiliated (NRA Logo).

GATE ENTRY

All competitors and officials receive free admission to the rodeo, a list of competitors and officials will be forwarded from NRA Office two (2) days prior to the rodeo.

With the Committee's approval only one (1) partner and/or parent/legal guardian entry will be half price (to be confirmed on the affiliation forms).

PAYMENT TO COMMITTEES

The NRA Office will do a direct deposit to the Committee for the committee levy and add back within 3 working days after receiving the paperwork from the rodeo. Please provide us with your bank details on the Rodeo Confirmation & Officials Form.

POSTED PRIZEMONEY PAYOUTS

The Committee have a couple of options regarding the posted prizemoney payouts. These options are: Payouts in Cash / Cheque or pay the prizemoney directly to NRA prior to the event and NRA will handle direct payments to the place getters.

ARENAS

All arenas used for rodeos are to be stock proof, including suitable fencing to prevent the escape of any animal from the arena or yarding facilities.

- (a) The arena must be completely top dressed or ripped to a minimum of 75mm and a maximum of 100mm. The minimum time event box length is 5 meters and minimum time event box width is 3 meters.
- (b) Portable arena sizes to comply with recommendations of NRA.
- (c) (i) Suitable transport is to be available in the case of injury of stock.
(ii) Suitable gate entrances are to be available for the moving of injured competitors.

BACKYARDS

For your safety, competitor safety and the safety of the sport, an area is too made available around the backyards, wherever possible, which is accessible to competitors only.

When the backyards are easily accessible by the public – Ropes and Signs designating No entry to the public and only Competitors are allowed past this point will help to endeavour the safety of the public along with competitors and their horses.

This applies to the Rough Stock competitors and access for Time Event horses.

These competitors and animals are very competitive and need to stay focused on their job at hand and not worry about interference from or the safety of the public.

FIREWORKS

As per the Queensland animal welfare stands and guidelines – animals at rodeos.

Fireworks must not be used in an arena while animals are in the same arena.

Steps must be taken to minimise the impact of fireworks or other noises that are likely to cause animals fear or distress.

COMPUTER DRAWS

As you are aware random computer draws are now done through the office before the rodeo – i.e. stock draws for Rough Stock Events and position draws for Time Events. This saves an enormous amount of time on the day of the rodeo.

Final numbers for each event will be emailed through to the committee by the NRA office on Thursday close of entries with updated numbers emailed on Monday once entries are finalized. The committee will then need to have a program sent to the NRA Office by Wednesday so the Draws can be uploaded to our website.

The committee must advise their stock contractor of these final numbers.

It is the responsibility of the stock contractor to contact the NRA Office before noon on Wednesday with the relevant stock numbers that they wish to include in the draw for the event. All stock must be registered with the NRA Office before they can be included in the draw. All stock must be clearly numbered when they arrive at the rodeo.

When there is less than 12 competitors in any open event the committee can request late entries to be taken with draws to be done on the day of rodeo by judges. Members or non-members can enter with late fees apply.
