AFFILIATION CLASSIFICATIONS

OPTION 1: **SUPER ALL-ROUND RODEO**

A super all-round rodeo consists of all eight (8) standard events with increased minimum prizemoney and maximum points for competition incentives and additional committee benefits.

❖ **Events:**

- Required six (6) standard men's events – *Bull Ride / Saddle Ride / Bareback Ride / Rope & Tie / Steer Wrestling / Team Roping*
- Required two (2) standard ladies' events – *Barrel Race / Breakaway Roping*
- Junior and/or novice events can only be conducted if the equivalent open event is being conducted.
- Additional approved rodeo events can be conducted. These events are listed in the Rule Book (on page 5).
- Team Roping may be conducted as a one (1) run event with double the minimum super prizemoney.

❖ **Prizemoney:**

- The minimum prizemoney totals \$12000.00, consisting of \$1500.00 minimum per standard event.
- Minimum prizemoney for the lowest-value standard men's and ladies' events must be equal.
- Optional rodeo events may be conducted with a minimum prizemoney of \$300.00 per event.
- Junior rodeo events may be conducted with a minimum prizemoney of \$50.00 per event.

❖ **Points:** Competitors receive full points and a half for all individual event titles and all-round titles.

❖ **Officials:**

- Must have an Animal Welfare Officer who is an NRA accredited official that has completed the NRA Animal Welfare Questionnaire and is a financial member for the corresponding season.
- Must have the following NRA accredited officials: two (2) Judges, one (1) Chute Boss, two (2) Timekeepers, two (2) Bull Fighters and two (2) Pick-Up Men.

❖ **Benefits:**

- Complimentary A4 advertisement on the NRA website and newsletter (supplied by the committee).
- Automatic entry into the draw to win free affiliation for the following rodeo season.
- Eligibility for consideration in the annual Committee of the Year award.

OPTION 2: **ALL-ROUND RODEO**

An all-round rodeo consists of all eight (8) standard events with lower minimum prizemoney and full points.

❖ **Events:**

- Required six (6) standard men's events – *Bull Ride / Saddle Ride / Bareback Ride / Rope & Tie / Steer Wrestling / Team Roping*
- Required two (2) standard ladies' events – *Barrel Race / Breakaway Roping*
- Junior and/or novice events can only be conducted if the equivalent open event is being conducted.
- Additional approved rodeo events can be conducted. These events are listed in the Rule Book (on page 5).
- Team Roping may be conducted as a one (1) run event with double the minimum standard prizemoney.

❖ **Prizemoney:**

- The minimum prizemoney totals \$6000.00, consisting of \$750.00 minimum per standard event.
- Minimum prizemoney for the lowest-value standard men's and ladies' events must be equal.
- Optional events may be conducted with a minimum prizemoney of \$300.00 per event.
- Junior rodeo events may be conducted with a minimum prizemoney of \$50.00 per event.

❖ **Points:** Competitors receive full points for all individual event titles and all-round titles.

❖ **Officials:**

- Must have an Animal Welfare Officer who is an NRA accredited official that has completed the NRA Animal Welfare Questionnaire and is a financial member for the corresponding season.
- Must have the following NRA accredited officials: two (2) Judges, one (1) Chute Boss, two (2) Timekeepers, two (2) Bull Fighters and two (2) Pick-Up Men.

❖ **Benefits:** Eligibility for consideration in the annual Committee of the Year award.

OPTION 3:

POINTS AWARD RODEO

A points award rodeo consists of at least three (3) or more of the standard events with half points.

❖ **Events:**

- Standard events: Bull Ride / Saddle Ride / Bareback Ride / Rope & Tie / Steer Wrestling / Team Roping / Barrel Race / Breakaway Roping.
- Junior and/or novice events can only be conducted if the equivalent open event is being conducted.
- Additional approved rodeo events can be conducted. These events are listed in the Rule Book (on page 5).

❖ **Prizemoney:**

- Minimum prizemoney of \$750.00 per standard event.

❖ **Points:** Competitors receive half points for all individual event titles only.

❖ **Officials:**

- Must have an Animal Welfare Officer who is an NRA accredited official that has completed the NRA Animal Welfare Questionnaire and is a financial member for the corresponding season.
- Must have the following NRA accredited officials: two (2) Judges, one (1) Chute Boss, one (1) Timekeepers, two (2) Bull Fighters and two (2) Pick-Up Men (if holding horse rough stock events).

OPTION 4:

BULL RIDE RODEO

A bull ride rodeo consists of an Open Bull Ride, Novice Bull Ride and U18 Junior Bull Ride with half points.

(Please note additional events may be conducted, but they must be sanctioned by the NRA Board of Directors).

❖ **Events:**

- Required events: Open Bull Ride, Novice Bull Ride and U18 Junior Bull Ride.

❖ **Prizemoney:**

- Minimum prizemoney total of \$3000.00, consisting of:
 - Open Bull Ride Minimum of \$2250.00
 - Novice Bull Ride Minimum of \$500.00
 - U18 Junior Bull Ride Minimum of \$250.00
- Additional open events may be conducted at the discretion of the NRA Board of Directors, with a minimum prizemoney of \$750.00 per event.
- Additional junior events may be conducted at the discretion of the NRA Board of Directors, with a minimum prizemoney to be determined.
- *Note:* If an additional non-bull ride event is added as above, the rodeo classification will be advertised as a Points Award Rodeo to indicate that other events are included for competitors.

❖ **Points:** Competitors receive half points for all individual event titles only.

❖ **Officials:**

- Must have an Animal Welfare Officer who is an NRA accredited official that has completed the NRA Animal Welfare Questionnaire and is a financial member for the corresponding season.
- Must have the following NRA accredited officials: two (2) Judges, one (1) Chute Boss, one (1) Timekeepers, two (2) Bull Fighters and two (2) Pick-Up Men (if holding horse rough stock events).

OPTION 5:

NON-POINTS RODEO

A non-points rodeo is any rodeo promotion that does not meet any of the other affiliation classifications or as determined by the NRA Board of Directors.

- ❖ **Points:** Competitors receive no points.
- ❖ **Officials:**
 - Must have an Animal Welfare Officer who is an NRA accredited official that has completed the NRA Animal Welfare Questionnaire and is a financial member for the corresponding season.
 - Must have a minimum of one NRA accredited official who has completed the NRA Knowledge Test, Animal Welfare Questionnaire and is a financial member for the corresponding season.
 - If having any bull rough stock events must have two (2) NRA accredited Bull Fighter.
 - If having any horse rough stock events must have two (2) NRA accredited Pick-Up Men.
- ❖ If there is prizemoney the event must have the following NRA accredited officials:
Two (2) Judges, one (1) Chute Boss, one (1) Timekeeper, two (2) Bull Fighters (if holding bull rough stock events) and two (2) Pick-Up Men (if holding horse rough stock events).
- ❖ If there is no prizemoney the selected officials in the capacity of a Judge, Chute Boss or Timekeeper must pay their insurance before officiating and be either a financial member for the corresponding season or a day member with a competed waiver and payment for the event only.

OTHER INFORMATION

This information applies to all rodeo affiliation classifications.

- ❖ **Optional Event Final:** A final may be conducted in an event with a minimum prizemoney of \$2250.00, subject to approval by the NRA Board of Directors. If an Event Final is held, the prizemoney will be divided equally between the first round, the final and the average. Points will be awarded on the average only.
- ❖ **Optional Rodeo Series:** A series may be structured with approval by the NRA Board of Directors. For more information, please contact the NRA Office. A Rodeo Series Agreement will be provided upon request to any interested committee.

The Board reserves the right to negotiate special terms for any rodeo affiliation.

Failure to comply with the requirements specific to your rodeo event's affiliation classification, or with the rules of the National Rodeo Association, will result in the matter being reported to the NRA Board of Directors for disciplinary review.

COMMITTEE CHECK LIST

The following checklist has been developed to assist committees with the conduct of their respective rodeo promotions.

If you require any clarification on any of the following points, please contact the NRA Office.

EVENT REGISTRATION

Please **register your event** with the Department of Primary Industries (DPI) and advise the ambulance and police in your area of your forthcoming rodeo.

PUBLIC LIABILITY

With regards to Public Liability, if your committee has its own Public Liability cover please provide a copy of the Certificate of Currency and Policy to the NRA Office with the affiliation form and fee. It has been noted that some Public Liability Policies do not include cover for rodeos. **Please look over your policy as the Certificate of Currency should state “Rodeo” in the “Description of Activities” or in “The Business”.** If your policy does not have this written down then the committee will likely not be covered for rodeo or if your policy has **“Rodeos (excluding any cover for claims inside the arena)”**, then the committee is not fully covered for rodeo as required.

For example: If there are any activities or exhibitions held in the break that require spectators to come into the arena or a spectator decides to enter the arena, backyards and or around the chutes area then public liability will be required to cover this.

With Gold level Cover with the NRA, you will be provided with an NRA Public Liability (20,000,000.00 Cover) Certificate of Currency that will include your event details and have your event fully covered.

TICKET SALES

The **NRA offers online ticketing services** for affiliated rodeo events via our website. Please contact the NRA Office to discuss options.

ADVERTISING

Committees **must display that the rodeo is NRA affiliated** in their event advertisement (e.g., programs, posters, flyers, etc.). The **NRA logo** is available to committees upon request for the use of the NRA affiliated Rodeo advertisements only.

SPECTATOR SAFETY

It is the **Committees responsibility to protect the safety of workers and the public**. As part of your risk assessment the NRA recommends the best way to do so is with **easily visible and informative signage** that alerts workers and the public to the hazard and informs them of the best way to avoid or remedy it. It is important to **keep the public out of high-risk areas** such as competitor areas including arenas, backyards and horse warm up areas to avoid any unfortunate and costly public liability claims. Clearly displayed signs around the grounds to keep the public clear of any hazards that you cannot remove. You can also secure these restricted or not permitted areas by sectioning them off with bunting, ropes, or fences with signage.

Please ensure that adequate safety precautions and actions are taken to inform the public that they must not be within one metre or on the arena fence. This is necessary as stock, competitors and officials may approach / use the fence and portable arenas are designed to move. **The public must be at least one metre away from the fence or portable panels.**

STRICTLY NO PUBLIC IS PERMITTED WITHIN 1 METRE OF THE ARENA, INSIDE THE ARENA, BEHIND THE CHUTES OR IN THE BACKYARD AREA. SAFETY MUST COME FIRST!

(We strongly suggest having security available, they can help ensure these requirements are enforced).

FIRST AID

It is **mandatory** that all committees have a qualified Level Three First Aid Officer in attendance whilst the rodeo is in progress. The **First Aid Officer must be Level three or above with a fully equipped vehicle** (i.e., have the defibrillator on board) to meet the requirements of insurance cover. First Aid Officers must have a **designated area** outside of the arena with vehicle access to the arena and clear access for a vehicle to leave premises in case of an emergency.

ANIMAL WELFARE

In the sport of professional rodeo, cowboys share the limelight with the rodeo livestock. For a cowboy to compete at the highest level, the livestock also must be in peak condition. Both are athletes in their own right. The very nature of rodeo requires a working relationship, and in some events a partnership, between the cowboys and animal athletes. The National Rodeo Association takes animal welfare seriously and is committed to complying with the animal welfare legislation relevant to the state or territory in which the rodeo is conducted.

It is expected that the operation of any rodeo in Queensland will be conducted in accordance with the **Queensland Rodeo Code of Practice**. From 1 January 2022, the Rodeo Code of Practice will be a **mandatory code** under the Animal Care and Protection Act 2001 (the Act). It contains the minimum acceptable standards of welfare for all animals being used at rodeos and rodeo schools.

It is expected that the operation of any rodeos in New South Wales will be conducted in accordance with the **NSW Code of Practice**. Compliance with the code will ensure that no offence is committed in relation to sections 18 and 18A of the Prevention of Cruelty to Animals Act 1979.

Both **Codes of Practice** require the rodeo organiser to ensure the following:

1. An **Animal Welfare Officer** (Livestock Handler) is appointed for the event. It is recommended that the principal stock contractor or judge be appointed as the Animal Welfare Officer.
2. A **Veterinarian** is appointed for the event – The veterinarian must be either in attendance at the event or be on call. If not on site and on call for the event the veterinarian must be available for consultation at all times animals are being used in, or are present at, the rodeo.
3. A **conveyance device** (vehicle) must be available to move a seriously injured animal safely and humanely to a suitable place for further examination and treatment. Suitable screening (e.g., hessian or tarpaulin) should also be available.

FIREWORK SAFETY

Firework precautions as per the Queensland Animal Welfare Standards and Guidelines – Animals at Rodeos:

1. Fireworks **must not** be used in an arena while animals are in the same arena.
2. Steps **must** be taken to minimise the impact of fireworks or other noises that are likely to cause animals fear or distress.
3. The Rodeo will require a break while the Fireworks are in progress and shall recommence once fireworks have ceased.

SITE INSPECTION CHECKLIST

The site inspection checklist is to be **completed and returned** to the NRA Office two weeks prior to your rodeo. If using a portable arena, then please notify the NRA Office and we can arrange for the site inspection checklist to be completed once the arena is assembled.

STOCK CONTACTORS & RODEO OFFICIALS

Stock contractors and rodeo officials **must** be NRA financial members and selected from the NRA accredited officials list which is published on our website: <https://www.nationalrodeoassociation.com.au/pages/Officials/>

Please **complete the Rodeo Confirmation and Officials** document two weeks prior to your rodeo with names of your Stock Contractor/s, Announcer, Judges, Chuteboss, Timekeeper/s, Pick-Up Men, and Bull Fighters – all of whom **must** be selected from the NRA accredited officials list.

ARENAS

All **arenas used for rodeos are to be stockproof**, including suitable fencing to prevent the escape of any animal from the arena or yarding facilities. Please see below the following **arena requirements**:

1. Portable arena to have a minimum height of 1800 millimetres (without prior approval of the Board).
2. Portable arena sizes shall be 30 x 30 metres for rough stock-only events (without prior approval of the Board).
3. The arena surface should be suitable for soil-based material or ground that is well drained, provides a secure footing and as safe for livestock as an appropriate soil-based surface. The surface must be completely top dressed or ripped to a minimum of 75 millimetres and a maximum of 100 millimetres.
4. Rodeos conducting time events must be a minimum of 50 metres from the catch pen to the time box front and a minimum width of 30 metres. The minimum time event box length is 4.8 metres, and minimum width is 2.4 metres.
5. Suitable gate entrances are to be available for the moving of injured competitors or stock.

BACKYARDS

For your safety, competitor safety and the safety of the sport, an **area must be available** around the backyards, wherever possible, which is accessible to competitors only.

When the backyards are easily accessible by the public, please use signage and fencing or bunting to identify and restrict the designated area (e.g., no entry to the public, competitors only past this point, etc.). This will help to **ensure the safety** of the public along with competitors and stocks.

This allows **access** for rough stock and time event competitors. Competitors in competitor designated areas should not have to worry about the interference from or the safety of the public.

RODEO OFFICE

Please make sure there is a **safe and secure office** provided near the arena vicinity with sufficient lighting, shelter, table, and chairs for the NRA Central Entries Officer to complete the required documentation for your rodeo.

BARREL RACE EVENT

Barrel requirement: Barrels must be 44-gallon size (200 litre) steel drums as standard with both ends closed.

GATE ENTRY

All **competitors and officials receive free admission** to the rodeo. A **rodeo gate list** of competitors and officials will be provided by the NRA Office two days prior to your rodeo.

At the discretion of the committee, one competitor's partner and/or one parent/legal guardian (18+) of a junior competitor may receive discounted or free admission. This is a selectable option on the Rodeo Information form.

POSTED PRIZE MONEY PAYOUTS

The committee has two options regarding the posted prize money payouts. These options are as follows:

1. **Payouts in cash or cheque** – completed either by the committee or NRA central entries officer at the event.
2. **Payouts by NRA direct deposit** – Deposit the total posted prize money into the NRA account two weeks prior to the event and NRA will complete direct deposit payments to the place getters.

Your preferred option is selectable on the Rodeo Confirmation and Officials form.

PAYMENT TO COMMITTEES

The NRA Office will complete a **direct deposit payment** to the committee for the **committee levy** within three business days upon receiving the documentation from their rodeo. Please provide us with your **bank details** on the Rodeo Confirmation and Officials form.

NOMINATIONS AND DRAWS

Random computer **draws are completed through the NRA Office** prior to the rodeo – i.e., stock draws for open rough stock events chute draws for novice and junior rough stock events and position draws for all time events.

Nominations for each event will be emailed through to the committee by the NRA Office on Thursday after central entries hours and updated nominations emailed on Monday once late nominations have closed, and entries are finalised. The **committee will be required to supply a program** to the NRA Office by Wednesday proceeding your rodeo so draws can be completed and uploaded to our website.

The **committee must advise their stock contractor** of these nominations.

It is the **responsibility of the stock contractor** to contact the NRA Office before 12pm on Wednesday proceeding the ride with the relevant stock numbers and names that they wish to include in the event draw. All stock must be registered with the NRA Office before they can be included in the draw. All stock must be clearly numbered when they arrive at the rodeo.

When there are **less than 12 competitors** in any open event the committee can request late entries extended to the day of the rodeo with the Central Entries Officer with draws to be completed by the judges before the rodeo commencement.

ACCREDITED MEDIA AND INFORMATION

The NRA maintains a list of **Accredited Media** who have been approved in accordance with the NRA Media Accreditation Policy and hold current accreditation. These individuals may request to **attend your affiliated rodeo** by notifying the NRA Office and receiving approval for inclusion on the Rodeo Officials' Gate List. This gate list, including any attending Accredited Media, will be provided to your committee at least **two days** prior to the rodeo.

Accredited Media will be identifiable by their western attire and have their NRA identification card displayed at all times during the rodeo.

Accredited media are permitted to position themselves beyond the bunting area at their own risk, except in areas reserved for safety or VIP access. Important: **No** accredited media or other media representatives are permitted inside the arena during the affiliated rodeo.

Regulation of public media is the responsibility of the committee, as they hold authority over the grounds. General attendees who are not Accredited Media may be permitted to capture content at your rodeo, at the committee's discretion. If permitted, they must remain within designated public areas only, comply with all event guidelines, and respect the rights and privacy of all individuals. Alternatively, committees may choose to enforce a **'no public media (photography or videography) policy'** by indicating this on the Rodeo Information Form.

If your committee plans to **engage a non-accredited or independent media representative**, please notify the NRA Office in advance and provide their business details along with a copy of their current certificate of currency.

If your committee intends to **restrict all media attendance**, you must inform the NRA Office at least **two weeks** prior to your rodeo to ensure this is communicated to interested Accredited Media. Without this notice, Accredited Media with NRA approval and inclusion on the Rodeo Officials Gate list are entitled to attend and capture content at the rodeo. Please note: The **NRA reserves the right** to appoint a minimum of one accredited media personnel to attend your affiliated rodeo on behalf of the association.

LOCAL RODEO ROYALTY QUESTING

If the committee decides to hold the Rodeo Queen and Princess competition, we kindly ask that sashes be provided for the winners in each category: Rodeo Queen, Rodeo Princess, and Junior Rodeo Princess, with the name of your rodeo included on each sash. We also encourage the committee to designate one member to serve as a judge for the competition. Our current rodeo queen will be in touch as your event date approaches.
