## **INTRODUCTION**

The National Rodeo Association Limited (NRA) is a registered Australian non-profit company. Originally established in 1966 as the Southeast Queensland Rodeo Riders Association, with the aim of supporting the cowboys and cowgirls who were unable to travel and compete on a full-time basis due to family or work commitments.

Today, the NRA serves as the governing body for affiliating rodeo committees across Southeast Queensland and Northern New South Wales. The Association provides standardised rule book for rodeo operations, conduct guidelines for members and rodeo personnel, and administrative support and insurance services for affiliated committees.

Animal welfare is of extreme importance to the NRA which has led to the adoption of the Animal Welfare Code of Conduct into the Association's Rule Book. The Code provides standards and guidelines that must be adhered to by members, competitors, and stock contractors alike to ensure the protection of all stock at rodeos. These measures ensure the ethical treatment and protection of all livestock involved in rodeo events.

### **Rodeo Royalty Titleholders:**

The **Rodeo Queen** and **Miss Fundraiser** serve as goodwill ambassadors and public representatives for the Association and sport of rodeo. These titleholders act as liaisons between rodeo personnel and the general public, promoting the sport and fostering community engagement.

### **Key Responsibilities:**

- Promoting the sport of rodeo and enhancing its public image
- Representing the NRA at events and media opportunities
- Organising and participating in grand entries – which involves the formal introduction of rodeo officials and event representatives, accompanied by a mounted procession of flag bearers including the Rodeo Royalty Team, and the national anthem.

The roles of **Rodeo Princess** and **Junior Rodeo Princess** are similar in nature, though tailored to be age appropriate. These titleholders share the same goal of promoting the sport and engaging with the community, with fewer responsibilities reflective of their age group.

### **Judging and Criteria:**

Entrants are assessed across five core categories – appearance, knowledge, horsemanship, personality, and fundraising/community spirit.

To be successful, entrants must:

- Demonstrate a sound knowledge of the sport and the Association
- Be a confident and capable rider with good horsemanship skills
- Present themselves and their horse with pride and professionalism
- Be friendly, approachable and articulate
- Demonstrate meaningful engagement in fundraising and community initiatives.

## **QUESTING GUIDELINES**

These guidelines apply to all entrants competing for the titles of Rodeo Queen, Miss Fundraiser, Rodeo Princess, or Junior Rodeo Princess.

### **The Crowning Quest:**

Judging of the crowning quest to crown the next Rodeo Royalty titleholders will occur at the National Finals Rodeo. The specific dates, times and information will be communicated to all entrants once confirmed by the Board of Directors. Any changes will be related as soon as possible.

### **Eligibility Criteria:**

Any female may compete in a Local Rodeo Quest (hosted at select all-round rodeos through the season). However, to be eligible for the Crowning Quest, entrants must:

- Be a current financial member of the NRA for the rodeo season
- Submit a completed nomination form and entry fee by the closing date
- Participate in a minimum of two local rodeo quests during the current rodeo season
- Submit all fundraising payments by the respective due dates

### **Additional category-specific requirements include:**

Junior Rodeo Princess:

- Must be 12 years or under as of January 1<sup>st</sup>
- raise the minimum fundraising amount of \$100

Rodeo Princess:

- Must be 17 or under as of January 1<sup>st</sup>
- raise the minimum fundraising amount of \$500
- Entrants who raise over \$1500 will automatically qualify for the Miss Fundraiser title

Rodeo Queen:

- Must be 18 years or over as of January 1<sup>st</sup>
- raise the minimum fundraising amount of \$1500
- Entrants who raise over \$1500 will automatically qualify for the Miss Fundraiser title

Miss Fundraiser:

- Eligible to any Rodeo Queen or Rodeo Princess entrant who raises over \$1500

### **Royalty Nominations:**

The nomination form for the 2026 Rodeo Royalty titles is included on **page 15** of this handbook. Nominations must be submitted to the **NRA Office by 3:00pm on Wednesday, 1<sup>st</sup> of October 2025**. Submissions must include a completed nomination form and the nomination fee of \$25.00 (*payable in addition to the fundraising amount*).

### **Fundraising Initiatives:**

Upon successful nomination, entrants may begin their fundraising activities. All funds raised must be recorded using the monthly reconciliation report, found on **page 16** of this handbook.

### **Monthly Requirements:**

- Funds raised must be deposit into the NRA bank account
- A complete reconciliation report **must** be submitted to the NRA Office

The NRA Office will maintain an ongoing tally of funds raised by each entrant throughout the season.

## **JUDGING**

### **Judges:**

The categories of Horsemanship, Appearance, Personality and Fundraising & Community Spirit will be assessed by a panel of five or more judges. To ensure a board perspective, at least one judge will be an individual who is not a current NRA member and does not regularly attend rodeos. Entrants will not be informed of the identities of the judging panel. A minimum eligibility score must be achieved to be considered for a title. All decisions made by the judges are final and not subject to appeal.

## **JUDGING CATEGORIES**

### **Interview:**

The Personality and Fundraising & Community Spirit categories will be assessed through a formal interview conducted by the panel of judges. All entrants must wear **black jeans and a white western shirt** during the interview.

Entrants will be assessed on their ability to communicate effectively, engage in conversation and express their thoughts clearly. The interview may include questions about the entrant's background, rodeo experience, community involvement and perspective on relevant social issues.

This interview helps judges gauge each entrant's potential to represent the National Rodeo Association and the sport of rodeo in public-facing roles.

### **Personality:**

Entrants are expected to display a happy, confident and approachable demeanour. Both entrants and title holders should engage warmly with the public and embody strong moral character and integrity.

## **Fundraising and Community Spirit:**

All fundraising efforts will be tallied and shared with the judging panel. Entrants will discuss their fundraising methods and community involvement during their interview.

Participation in additional charitable and community activities is strongly encouraged and viewed positively by the judging panel, although not mandatory. Contributions within the rodeo community will also be considered.

Examples of favourable activities include:

- Raising funds above of the minimum requirement
- Assisting the reigning Rodeo Queen with grand entries
- Supporting junior rodeos and competitors
- Helping to organise raffles (with prior approval of the NRA Office)
- Volunteering at community organisations (e.g. animal shelters, hospitals, retirement homes)
- Assisting at NRA functions and events.

These activities help demonstrate initiative, community engagement, and commitment to the values of the NRA and the sport of rodeo.

## **Appearance:**

Entrants will be assessed on appearance during the horsemanship component. This includes both personal appearance and appearance of the entrant's mount and tack.

**Personal Appearance** – Entrants may choose their own attire, provided it complies with the NRA dress code regulations. Regardless of style, all attire should be clean, well-pressed and properly fitted.

### **Key considerations:**

- Hats should be clean, well-shaped and fitted to keep the entrant's face visible
- Boots should be clean and free of scuff marks
- Consider the venue lighting when selecting attire colours
- Avoid excessively tight or baggy clothing
- Sheer or revealing outfits are not acceptable
- Facial piercings are undesirable, multiple earrings and visible tattoos are undesirable
- Chaps are not permitted.

**Appearance of Mount and Tack** – Cleanliness and presentation are key. Judging is not based on the value or age of the horse or tack, but rather their presentation, fit and appropriateness.

### **Key considerations:**

- Horses should be in good health, well-groomed and with good hoof care
- White markings should appear clean (reasonable allowances for any discolouration caused by the arena conditions)
- Tack should fit properly and be suitable for its intended use
- Protective boots or wraps are optional, but should match and enhance the overall appearance

## **Horsemanship:**

Horsemanship will be evaluated through a ridden pattern conducted in the arena.

Judges will assess the entrant's ability to control their mount and present themselves confidently and professionally from horseback. Rodeo Queen and Rodeo Princess entrants will be given the opportunity to demonstrate flag-carrying skills during a designated section. For safety, if an entrant or their horse is not capable of safely carrying a flag, they must not attempt it. They may instead perform the royalty wave during this section.

Judging criteria includes:

- Entrants' ability to maintain full control of the horse at all time
- Entrants' demonstration of horsemanship skills
- Entrants' ability to follow directions and complete the required pattern and manoeuvres accurately
- Horses' responsiveness and free movement throughout

## **Safety requirements:**

- Rodeo Princess and Junior Rodeo Princess entrants must wear an approved helmet
- Rodeo Queen entrants under 18 years of age at the time of judging must also wear an approved helmet
- All other entrants may choose between a helmet or a western hat, with no penalty for either choice.

## **Knowledge:**

Entrants will complete a written exam to assess their knowledge, and each will receive an individual score based on their performance. Exams will be conducted in groups according to royalty category (e.g. all Rodeo Princess contestants will sit the exam together). Any entrant found cheating will be immediately disqualified from the Quest.

Entrants will be tested on their knowledge of the sport of rodeo, the National Rodeo Association, Animal Welfare Code and public relations. All entrants are expected to have a strong understanding of the following matters:

- The NRA Rule Book
- Animal welfare guidelines as outlined in the NRA Rule Book and Queensland Animal Welfare Standards and Guidelines – Animals at Rodeos document
- NRA history
- General rodeo knowledge
- Equine anatomy and health
- Western tack and equipment
- Other topics relevant to the sport of rodeo

Entrants should be confident discussing rodeo and equine topics with members of the public. Titleholders are public representatives of the sport of rodeo and must be prepared to explain rodeo rules and concepts clearly and have good awareness of current events to support effective public engagement.

**Important:** Personal opinions about the NRA, its Board of Directors, or animal welfare issues must not be shared. Any such enquiries must be directed to an NRA Director.

The level of knowledge expected will be appropriate to each royalty category. Accordingly, three versions of the written exam will be provided, each tailored to the relevant category.

We strongly encourage all entrants to review the NRA Rule Book and the Queensland Animal Welfare Standards and Guidelines, available on the NRA website.

**Tally of Points:**

Following the completion of all judging sections, the NRA Office Manager and two members of the judging panel will tally and verify all scores.

In the event of a tie, the horsemanship score will be used as the first tiebreaker. If the tie remains, the knowledge score will be considered next, followed by appearance, and finally, personality.

Each stage of the tie-break process will be applied in sequence until a clear winner is determined.



## **GENERAL REQUIREMENTS FOR ENTRANTS**

All entrants and titleholders must uphold the highest standards of conduct and professionalism. The following rules apply to all participants:

- Entrants must comply with all NRA rules and regulations, including those outlined in this handbook, without exception.
- Entrants must refrain from smoking in public while representing the NRA.
- Entrants must adhere to the NRA Drug and Alcohol Policy, including a strict no alcohol consumption rule while wearing their official entrant sash.
- Entrants must wear their official entrant sash at all fundraising and promotional activities. Sashes must not be worn while competing in rodeo events.
- Inappropriate conduct such as yelling, swearing, or arguing will not be tolerated.
- Entrants must not make derogatory or offensive remarks, including via social media or other public platforms.
- Entrants must not express personal opinions regarding the NRA, its Board, its rules or decisions, or any animal welfare matters. All such enquiries should be directed to an NRA official.
- Appropriate western attire is required for all quest-related promotional and fundraising events.
- Entrants are expected to attend all rounds of the NRA Finals and assist the Rodeo Queen with tasks as requested.

Failure to adhere to any of the above requirements may result in disqualification from the quest, with nomination fees forfeited.

## **QUEST AWARDS**

At the conclusion of the Crowning Quest, the following titles and awards may be presented:

### **Rodeo Queen Category**

- Rodeo Queen
- Runner-Up Rodeo Queen

### **Miss Fundraiser Category**

- Miss Fundraiser

### **Rodeo Princess Category**

- Rodeo Princess
- Runner-Up Rodeo Princess

### **Rodeo Junior Princess Category**

- Junior Rodeo Princess
- Runner-Up Junior Rodeo Princess

### **Additional Awards**

Subject to entrant numbers the following additional awards may be presented:

### **Prizes:**

The following prizes will be awarded to titleholders:

- Rodeo Queen, Miss Fundraiser, Rodeo Princess, and Junior Rodeo Princess will each receive a trophy buckle.
- If there are at least three Rodeo Queen entrants, each having raised the minimum of \$1,500 fundraising amount, the Rodeo Queen winner will also receive a trophy saddle as part of her prize.



# **TITLEHOLDER RULES AND RESPONSIBILITIES**

All titleholders must fulfil the responsibilities outlined below for the duration of their reign. Failure to meet these expectations may result in the forfeiture of the title, in which case the runner-up will assume the role.

## **Rodeo Queen**

### **Core Responsibilities:**

- Actively promote the NRA, its affiliated rodeos and the sport of rodeo throughout their reigning season.
- Work in collaborate with the NRA Office Manager, Miss Fundraiser, Rodeo Princess, and Junior Rodeo Princess to coordinate and participate in promotional or fundraising activities.

### **Personal Presentation:**

- Maintain a consistently high standard of presentation for both yourself and your horse, reflecting the professionalism expected of Rodeo Royalty.
- Take responsibility for the care and safe transport of the Rodeo Queen crown, chaps, and grand entry flags, which remain the property of the NRA.

### **Rodeo Committee Engagement:**

- Contact affiliated rodeo committees to introduce yourself as the current Rodeo Queen, offer support with any promotional activities and discuss the opportunity to host a Local Rodeo Quest.
- If a Local Rodeo Quest is to be held, assist the committee by:
  - Helping to secure judges, sashes, and optional prizes (note: sashes should be supplied by the committee if they opted for a quest. Prizes are not compulsory).
  - Politely offer the committee the option to nominate a judge.

### **Grand Entry Duties:**

- Organise and lead the grand entry with the Australian Flag at all affiliated all round and super all round rodeos.
- Review the rodeo program and draws (available on the NRA website after 12:00pm Wednesday) to prepare the grand entry list.
- Submit the final grand entry list to the NRA Office by Thursday to ensure it can be included with the published rodeo program and draws.
- Wear the Rodeo Queen chaps during the grand entry only and ensure all grand entry flags are transported to and from events with care.
- If unable to attend an all round or super all round rodeo:
  - Notify the NRA Office in advance.
  - Arrange for the Miss Fundraiser to fulfill your responsibilities. If she is also unavailable, delegate duties to the Rodeo Princess or a suitable NRA member.
- Grand entries are optional for all affiliated rodeos and are held at the committee's discretion.

### **Administrative and Promotional Tasks:**

- Actively promote all Rodeo Royalty Quests throughout your reign.
- Support, encourage, and mentor current quest entrants.
- Assist in the delivery of the end-of-year crowning quest, in coordination with the NRA Office Manager.
- Optionally seek sponsorships or prize donations for the crowning quest prizes (encouraged but not mandatory).
- Assist the NRA Office with the pack down of Presentation Night in the year you are crowned and in organising the following year's Presentation Night.
- Provide general support to the NRA Office throughout your reign as needed.

### **Local Rodeo Quests:**

As Rodeo Queen, you are responsible for supporting the successful execution of Local Rodeo Quests. This includes:

- Recruiting suitable judges (you must not serve as a judge or influence judging decisions).
- Ensuring the award format includes only:
  - A sash for each title: Queen, Princess and Junior Princess.
  - An optional prize, if a committee or sponsor chooses to provide one.
- Ensuring the horsemanship pattern remains simple and accessible (e.g., one large circle, followed by a figure-pattern pattern and clean stop). No flag work should be included in these local horsemanship patterns.
- Judging appearance of mount and tack can have reasonable allowances for arena and weather conditions, if necessary.
- Ensuring interview questions remain simple and avoid technical content.

### **Miss Fundraiser**

#### **Core Responsibilities:**

- Actively promote the NRA, its affiliated rodeos and the sport of rodeo throughout their reigning season.
- Work in collaborate with the NRA Office Manager, Rodeo Queen, Rodeo Princess, and Junior Rodeo Princess to coordinate and participate in promotional or fundraising activities.

#### **Personal Presentation:**

- Maintain a consistently high standard of presentation for both yourself and your horse, reflecting the professionalism expected of Rodeo Royalty.
- Take responsibility for the care and safe transport of the Miss Fundraiser crown, which remain the property of the NRA.

#### **Event Duties:**

- Assist the Rodeo Queen with the coordination of grand entries at affiliated rodeos as required.
  - If the Rodeo Queen is unavailable, the Miss Fundraiser will conduct and lead the grand entry with the Australian Flag on her behalf.
- Assist the Rodeo Queen with the organisation of Local Rodeo Quests as required.

#### **Administrative and Promotional Tasks:**

- Actively promote all Rodeo Royalty Quests throughout your reign.
- Support, encourage, and mentor current quest entrants.
- Assist in the delivery of the end-of-year crowning quest, in coordination with the NRA Office Manager.
- Optionally seek sponsorships or prize donations for the crowning quest prizes (encouraged but not mandatory).
- Assist the NRA Office with the pack down of Presentation Night in the year you are crowned and in organising the following year's Presentation Night.
- Provide general support to the NRA Office throughout your reign as needed.

### **Rodeo Princess and Junior Rodeo Princess**

#### **Core Responsibilities:**

- Actively promote the NRA and the sport of rodeo throughout their reigning season.
- Work in collaborate with the NRA Office Manager, Rodeo Queen and Miss Fundraiser to coordinate and participate in promotional or fundraising activities.
- Assist the Rodeo Queen and Miss Fundraiser as required.
- Support, encourage, and mentor current quest entrants.

**Personal Presentation:**

- Maintain a consistently high standard of presentation for both yourself and your horse, reflecting the professionalism expected of Rodeo Royalty.
- Take responsibility for the care and safe transport of the Rodeo Princess crowns and chaps, which remain the property of the NRA.

**NRA Office Manager****Core Responsibilities:**

- Supervise all titleholders to ensure they are fulfilling their duties and adhering to NRA rules and conduct.
- Oversee the coordination and management of all Rodeo Royalty responsibilities and activities.
- Serve as the primary point of contact to address any concerns or queries from entrants, parents, or members regarding Rodeo Royalty matters.
- Address and resolve any conflicts related to Rodeo Royalty and if necessary, refer unresolved issues to the NRA Board for further review.
- Ensure the Rodeo Royalty Handbook is current, accurate, and that all parties remain in compliance with its contents.
- Manage and reconcile all funds associated with Rodeo Royalty and approve any related financial transactions.
- Maintain an active, supportive role throughout the season, offering guidance and assistance to titleholders and their families.

**Rules and Conduct for Rodeo Royalty Titleholders:**

To uphold the values and public image of the NRA, all titleholders must adhere to the following rules throughout their reign. Breaches may result in the forfeiture of title.

- Must adhere to all NRA rules and regulations at all times – no exceptions.
- Must not be seen smoking in public.
- Must comply with the NRA Drug and Alcohol Policy and must not consume alcohol while wearing the NRA Crown.
- Must wear the NRA Rodeo Royalty Crown at all NRA rodeos and functions, excluding when competing in rodeo events.
- Must be dressed in appropriate western attire in accordance with the NRA Dress Code at all rodeos, quests, promotional and fundraising events.
- Must wear the designated rodeo royalty chaps during grand entry appearances only.
- Must not compete in any royalty quests during her reign or within 12 months following her reign.
- Must maintain appropriate public conduct, and refrain from any undesirable behaviour, including:
  - Yelling
  - Swearing
  - Arguing
- Must not make or share derogatory statements by any means, including via social media platforms.
- Must not express personal opinions regarding:
  - The NRA or its Board of Directors
  - NRA rules or decisions
  - Animal welfare topics

By submitting a nomination, all entrants acknowledge and accept that such changes may occur. No entrant shall withdraw or contest her nomination on the basis of these adjustments. If any such modifications are made, all registered entrants will be notified immediately.
